

GLASS BREAKAGE

NO FAULT

LIFETIME RESIDENTIAL GLASS BREAKAGE NON-PRORATED, TRANSFERABLE LIMITED WARRANTY

Lifetime glass breakage coverage for the original purchase/property owner and 20 years for the succeeding owner.

Kensington HPP, Inc., manufacturer of residential replacement vinyl windows, makes available to the original purchaser or present residential property owner the Lifetime Non-Prorated Transferable Limited Warranty, warranting against glass breakage for as long as the property owners (single family, owner occupied) shall own or reside in the home in which the products were installed from the date of window installation.

If glass breakage does occur within the time period specified according to the provisions of the Warranty, then Kensington HPP, Inc. agrees to provide the replacement glass free of charge, F.O.B. Kensington HPP, Inc.

This warranty is valid only so long as the windows are installed on the premises of the original installation. Removal of the windows invalidates this Warranty. As described above, this Warranty is limited to the material cost of the glass and does not extend to labor costs. Kensington HPP, Inc. will not be responsible for any costs incurred in the removal or reinstallation of the glass furnished by manufacturer under this warranty. This Warranty does not cover acts of God such as Hurricanes, Floods, Earthquakes, etc. Additionally this Warranty does not include the following glass types: specialty shapes, tempered, laminated, grooved or leaded.

CLAIMS PROCEDURE

Submit Warranty claim in writing to the appropriate Kensington HPP, Inc. Dealer. This Warranty shall be for the benefit of the original purchaser/property owner, and shall be transferable. Upon transfer the Warranty will convert to a 20 year non-prorated limited warranty from the original date of purchase. When the Warranty is transferred, the new property owner submits the original Warranty, along with a statement of his or her name and address of the property to the appropriate Kensington HPP, Inc. Dealer when a claim is to be made. It is limited to the manufacturer furnishing new glass, free of charge, F.O.B. Kensington HPP, Inc. In the event of such replacement, the remaining portion of the original Warranty period shall continue in effect and cover the replaced glass.

This Warranty is valid in those states where permitted. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. You should check the local state laws to determine this. This Warranty gives you specific legal rights, any you may also have other rights which vary state to state.

THE WARRANTY SET FORTH IN THE FORGOING PROVISIONS OF THE CERTIFICATE ARE LIMITED TO THEIR PRECISE TERMS AND PROVIDE EXCLUSIVE REMEDIES EXPRESSED IN LIEU OF ALL OTHER WARRANTIES.

ANY IMPLIED WARRANTIES IMPOSED BY LAW SUCH AS THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN TIME TO THE EXPRESS DURATION OF THIS WARRANTY. Kensington HPP, Inc. IS NOT LIABLE TO ANYONE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY WRITTEN OR IMPLIED WARRANTY FOR ITS VINYL REPLACEMENT WINDOWS. THE DEALER IS NOT AUTHORIZED TO OBLIGATE Kensington HPP, Inc., EXCEPT STRICTLY IN ACCORDANCE WITH THE TERMS AND CONDITIONS OF THE CERTIFICATE.
